- **21.013 Apologies** had been received from Cllr S Green and Cllr M Page both were accepted.
- 21.014 There were no **Declaration of Interest**
- 21.015 Public time: Cllr A Page reminded the members of the public that they had 3 mins each to allow all a chance for question and reply. Going forward the public are requested to inform the Clerk by email prior to the meeting if they wish to speak A resident asked the Parish Council if he needed permission to remove several trees from his garden, he is on the edge of the Conservation Area although not in it. His property backs onto the Willow Brook. Cllr Shepard advised that he should perhaps get in touch with the Environment Agency just to confirm that it is not their responsibility. All councillors were happy for the work to go ahead. A resident also showed an interest in joining the Neighbourhood Planning Development Committee, Cllr Vickers proposed that he contacts the Clerk with his details.
- 21.016 Borough Councillor Alexandria Wellings gave the following report Cllr Wellings knows that Borough Councillor Kevin Watt has been in contact with Jason Smithers with reference to the traffic survey and believes that a full traffic survey will be carried out once the traffic gets back to near normal. Corby Borough Council are formally becoming Corby Town Council. Following on from the complaints received about the Planning Department the Chief Executive Office are investigating. There is a Rural Forum meeting on Thursday evening, the Clerk will be attending on behalf of the Parish Council.
- 21.017 Cllr S Taylor proposed that the Minutes of the Meetings held on Monday 12th

 January be accepted as a true record, second by Cllr Shepard and approved by everyone. The minutes were electronically signed.
- 21.018 Matters Arising
 - a) Weldon Traffic Update and Consultation Update Cllr S Taylor informed the meeting that a meeting had been held between Persimmon, CBC and NCC with a view to opening Spine Road late April/early May. Cllr Taylor is also meeting with a gentleman to discuss turning the whole of Weldon into a 20mph speed limit zone. They have confirmed this is part of the consultation with the new school on Weldon Park.

- b) **Pedestrian Crossing for Priors Hall zone 1 to join Weldon,** Cllr S Taylor informed the meeting that Cllr M Page is waiting for a quote for the overview drawings.
- c) **Road Sign for Church Walk** No further update on this matter, Cllr S Taylor to chase.
- d) **Parish Ownership** Cllr S Taylor confirmed that the legal documents for the Gandy Field should be with the Parish Council in the next few days. Nothing further to report on the Leys or Brambleside, Cllr S Taylor to chase Persimmon on both.
- e) Cllr S Taylor agreed to be the **Police Liaison Representative to act as a single point of contact with Northamptonshire Police.**

21.019 Reports from

a) Parish Maintenance - Cllr Shepard reported that the viewing platform in the Pocket Park has been erected along with some of the fencing. He thanked Mr Peter Dowsett, a resident called Paul (he only has his christen name), Cllr Priem and Mr Cox for their help. The rest of the fencing will be completed in the next week or so. The old animal shelter has not been removed due to the weather conditions.

Cllr Shepard highlighted concerns about the amount of blocked drains around the village. Cllr S Taylor confirmed that the drain in Bridge Street is being looked into, the Clerk has reported the one on Corby Road by the junction of Hillside Crescent on Fix my Street. NCC have sent the Village Warden around the village who has confirmed that NCC are planning to carry out jetting and gully sucking on all the drains.

Some salt bins are empty and Cllr Shepard has reported this to Fix my Street.

Cllr Groom is concerned about the trees overhanging Oundle Road from the Rookery, this is private land and as such the Parish Council are not responsible. Borough Councillor Wellings suggested contacting County Councillor Naden-Horley.

The Clerk has had several residents come forward to help with litter picking when restriction allow.

- b) **HR committee** Cllr A Page confirmed that the committee will be meeting on Tuesday 9th February.
- c) NPD Committee Cllr Vickers informed the meeting that he had only received the documents at short notice which were forwarded to all Councillors by the Clerk just prior to the meeting. Following from these documents it was agreed to hold a committee meeting on Thursday 11th February.
- d) The Clerk read out the following **School Report -**25 30% of our pupils are still physically attending school. This varies day-to-day in-line with the shift patterns of parents/guardians. All staff are in school teaching those children present and hosting live lessons for those children who are being homeschooled. Children are taught in year-group bubbles. Our home-schooling provision consists of: live Zoom lessons for English and Maths; home learning packs for all core subjects; pre-recorded interactive YouTube lessons for Music; online learning; Zoom drop-in sessions to discuss any concerns or to catch-up with classmates / teaching staff; Zoom and pre-recorded story sessions; PE activities, and assembly / worship sessions. This can all be viewed on the class pages of our school website. We've provided electronic

devices for those children who don't have access to such equipment at home and we're in regular telephone contact with families who are finding this lockdown particularly difficult. We recognise what a challenging time this is for children and their families. Teaching staff are in email contact with all families at least once a week. Our staff have worked incredibly hard to adapt to this new way of working, ensuring the transition has been as smooth as possible for the children. Our children continue to amaze us with their resilience and can-do attitudes, evident in the quality and quantity of work that's being submitted to our teaching team on a daily basis.

21.020 Finance
