FC.532 Budget 2025/2026

The Clerk produced the budget, a few amendments were made

- Increase budget for photocopier and laptop from £1,000 to £1,500
- Include 20mph zone traffic calming into 2025/2026 budget £10,000
- precept to keep as 2024/2025
- Weldon in Bloom, Cllr Taylor suggested that St Marys Church apply for a
 grant to cover costs of wool for yarn bombing around the village. Cllr
 Gibson proposed that there is a plot on the allotments that could
 become a green space to grow plants etc to help reduce costs for plants
 in the planters around the village and to include the schools, this was
 agreed by Cllrs Taylor and Cooke.

Other queries raised

- What happens to the precept claimed from NNC when a residents moves into the parish during the year, Clerk to contact Danny at NCALC to query this
- Clerk to contact Danny at NCALC regarding charging NNC for grass cutting that we cover and pay a contractor to complete
- **FC.533** Grant application received from St Marys Church, Weldon for £3,390 to cover grass cutting and Little Stars group, this grant application to be taken to full council in January.

To review rules in the grant policy in the new year (2025), slight amendments may be needed.
